The Joint Review Board asked Brasser and Peterson to make statements regarding their desire to serve as the Public Member of the Joint Review Board (JRB). Joseph Lotegeluaki was not present.

Brasser stated the TIF policy is important not just for the City, but for the overlying taxing jurisdictions as well. The JRB is a public entity that does important work. He said that he currently chairs the City's CDA and that the elimination of blight is extraordinarily important and that he would like to help.

Peterson said that he is a member of the American Institute of Certified Planners (AICP) and operates under their code of ethics. This is a major responsibility to the public. He has helped create 38 TIDs in 15 different communities. He has helped create Business Improvement Districts (BIDs), conducted blight studies in Madison, helped create 1/2 Mile rule approvals, and been active in TIF policy. He was involved with municipal funding for various projects including CDBG and Clean Water.

Ramakrishna was asked if there was any conflict of interest with Brasser serving on the CDA. Ramakrishna stated that there was not.

Hicklin nominated Brasser, based upon experience and synergy with the CDA. Second by Mertz.

Brasser was elected unanimously.
