3. 13520 Report from the Chairperson of the Disability Rights Commission

Jeffrey Buhrandt welcomed newest member of the Commission, Bella Sobah and introduced Kristen Luppino, prospective Commission member.

Chairperson Buhrandt also reminded Commission members of their responsibility to attend meetings.

4. 45844 Report from the Accessible Housing Strategy Work Group

Nothing to report, Work Group has not recently met.

5. <u>15340</u> Report from the Department of Civil Rights

Jason Glozier reported on a recent project from the City of Madison Clerk's Office, the Wisconsin Council on the Blind and Visually Impaired, and the State's Election Commission to educate the public and election officers on accessibility in election materials and polling locations.

Glozier also spoke of the ongoing discussion with Metro regarding changes to Paratransit program. Metro recently used a Racial Equity and Social Justice tool to analyze how its proposed changes would have disproportionate effects. Metro has postponed making any decision on door-to-door service and leave attended policy until the 2019 Budget.

6. 24056 Report from the Rev. Dr. Martin Luther King, Jr. Humanitarian Award Commission

Ali Muldrow and Gaddi Ben Dan were honored at the 33rd annual City-County Martin Luther King Jr. Observance on January 15th 2018.
