APPROVAL OF MINUTES

NEW BUSINESS

1. 27499 Public Market Discussion

Public Market Mission Follow Up – members were asked to complete PMDC Exercise Step 2

Market Ready Update – Michael Miller provided an update. Micro grants were a motivator for both those groups that received a grant and those that didn't. Legal needs assessment available for remaining 29 participants. UW Legal Clinic and Boardman & Clark are participating in providing legal assessments. Discussion of 2019 Budget request and if a new cohort should be created or keep and continue to provide technical assistance to existing cohort. Public Market will not open until 2020. Request for \$100K. Palm requested that Economic Development Division estimate what a cohort of 10 would cost.

Funding Updates – New Market Tax Credit still in pipeline for funding. No new information at this time. October 18 Taste of the Market event invite went out. Hoping for 150 attendees. Also planning for a holiday event as a virtual promotion. Project is reauthorized for funding. Approved by Finance Committee. Nov 11/12 goes to Common Council.

Project Background and Status Report was reviewed. This document provides background on the history of the project. This will go out to alders on Monday, October 8.

Public Market Foundation Update – A copy of the draft collaboration agreement was distributed for informational purposes. City staff and Foundation have approved draft. This document lays out both City and Foundation responsibilities. This document leads into an Operating Agreement and Lease.

Design/Development Process Update – RFP to hire Architect and Engineering team went out. Eleven responses. Six lead by Madison based architecture firm. Short list of five were interviewed. Currently doing due diligence, reference checks, and requests for additional information.

Four more major items will require Common Council approval:

- Collaboration agreement
- · Execution of contract with architect and engineering team
- Term sheet to purchase land (Letter of Interest)
- TIF with developer

Predesign, land use approvals, certified survey map, demolition are also part of the process. Environmental remediation, soils, structured parking are justifications for TIF.
