- 3. Test model binders with UDDs, guidelines, etc. These will be brought to each meeting as reference materials for Commission members. Members are asked to relay any suggestions to the Secretary (color coding, tabs). The Commission Policy document should be added. Is there a way to put it online?
- 4. Goodhart: Why is Femrite Drive (that part of the City) in Urban Design District No. 1? To change that, does it begin here? The Chair responded that if Goodhart has a suggestion it can start here. The Commission can revisit boundaries and consider redistricting. The Chair elaborated that the Commission only deals with the projects, not evaluation of what an Urban Design District has done for an area. Enforcement is an issue. Having Femrite in the district holds that industrial area to a standard that others don't. Whether it works or not is another question. The Secretary noted she would like to start reevaluating the districts and how to handle that process, thinking about the bigger picture. It was suggested that when there is a smaller agenda these

topics could be discussed and a work plan enacted, bigger than a project by project review. Put on your thinking caps.
