EDA Application Update

 Reynolds gave overview on status still waiting to hear back but should be optimistic.

Men's Shelter

- Abbas gave update on public meetings said outreach was extensive and had decent response.
- Rummel felt Porchlight did a nice job with putting together policies for the shelter.
- B. Pauba Said because of shelter less will need to be done in getting facility ready for renovation.

Public Market Design

- Pauba said design is close to completion finishing up construction documents sometime around end of February.
- Pauba felt BID process could start in summer of 2021.

TIF Update

- Mikolajewski gave TIF update on presentation of Joint TIF Review Board
- Mikolajewski provided an update of timeline up to construction phase.
- Day Farnsworth asked about back-up plan if EDA grant falls through
- MM said no real back-up plans if EDA grant isn't awarded
- Day Farnsworth suggested EDA could connect project to other funding opportunities.
- Peterson asked about contingent plans for temporary men's shelter.
- MM said staff team working on shelter feels good about finding a permanent shelter.

Foundation Update

- Reynolds felt meeting with City staff has been positive.
- Reynolds said Foundation has been fundraising and is impressed with continuous involvement of the community with all the timeline changes.
