## Body

DRAFTER'S ANALYSIS: This Subsitute Ordinance was created at the request of the applicant and rezones

property located at 4205 Portage Road, 17<sup>th</sup> Aldermanic District, from Temp. A (Temporary Agricultural) District to TR-U21 (Traditional Residential-Urban 21) for future multi-family development.

The Common Council of the City of Madison do hereby ordain as follows:

1. Map Amendment 00482 of Section 28.022 of the Madison General Ordinances is hereby created to read as follows:

"28.022-00482. The following described property is hereby rezoned to TR-U21 (Traditional Residential-Urban 2 1) District:

Lot 2 of Certified Survey Map Number 12909, City of Madison, Dane County Wisconsin. Said described area contains 11.35 acres, more or less."
