### Fiscal Note

The proposed resolution approves a purchase of services contract for architectural/engineering design services and construction administration services for a new park shelter in Door Creek Park on Littlemore Drive. The cost of this agreement is \$155,000, which is budgeted within the 2020 Adopted Capital Budget for Engineering - Facilities Management, Park Facility Improvements. In 2020, \$975,000 of GF GO Borrowing is budgeted within the program for these costs. No additional City appropriation is required for this project.

### Title

### Body

WHEREAS the 2020 Capital Budget includes funding for architectural and engineering consultant design, bidding, and construction administration services; and,

WHEREAS Aro Eberle Architects has been selected through a "Request for Proposal" process, and is the final selected candidate in accordance with MGO Section 4.26 of Madison General Ordinances; and,

WHEREAS the scope of this project shall include architectural/engineering services for the Door Creek Park Shelter that will achieve at a minimum LEED Certification-Silver per Madison Legislative File #07453 following the U.S. Green Building Council's LEED for New Construction and Major Renovations (LEED-NC v. 3) Rating

System; and,

NOW, THEREFORE BE IT RESOLVED that the Common Council hereby authorizes the Mayor and City Clerk to enter into a contract for Purchase of Services (Architect) in a form to be approved by the City Attorney, with Aro Eberle Architects to provide professional architectural/engineering design services and construction administration services for the Door Creek Park Shelter.
