#### **Body**

WHEREAS, the City of Madison's official logo is a symbol of jurisdiction of the City which makes it a valuable asset of the City and its citizens; and

WHEREAS, the current City logo uses graphical styles and cursive font from a branding style that is nearly 20 years old; and

WHEREAS, the buildings on the left hand side of the logo are not accurate to the current City skyline thereby dating the logo in terms of area construction; and

WHEREAS, City Engineering has used a logo which is classic, iconic and familiar to the public as seen on City bridges, utility covers and other facilities which also gives it an enduring quality;

NOW, THEREFORE, BE IT RESOLVED that the Common Council hereby approves of formally adopting the logo used by the Engineering Department as the official City of Madison logo which would replace the current
