### Fiscal Note

In the adopted 2016 capital budget the Sewer Utility has budgeted \$950,000 for the extension of sanitary sewer to serve the Lower Badger Mill Creek Watershed (MUNIS 10922). The minor project for phase 3 of the work is established with sufficient budget authority for the estimated cost of \$766,870.

The proposed resolution awards the contract at an estimated cost of \$766,870.
