### Fiscal Note

As stated in the Employment Agreement between the City of Madison and Gregory P. Mickells, the Library Director's initial year's salary will be based on a total annualized rate of \$140,044 effective September 3<sup>rd</sup>, 2017. The Library's 2017 operating budget includes sufficient funding for the costs. Annual salary adjustments may be made during the term of the agreement at the Mayor's discretion, subject to Common Council approval.

WHEREAS, Mayor Soglin has appointed Gregory P. Mickelss to the position of Library Director and has recommended to the Common Council that his appointment be confirmed; and
