**Fiscal Note**

The proposed resolution reclassifies position #4294 from CG18 Range 8 to CG18 Range 10. The cost of this reclassification for the remainder of 2017 is approximately \$2,265, including benefits. The cost will be absorbed within the Community Development Division’s 2017 Adopted Operating Budget. The annualized cost of this reclassification is approximately \$5,880, including benefits.
