**Fiscal Note**

The proposed resolution approves plans and specifications and authorizes the Board of Public Works to advertise and receive bids for work related to the W Main St Bike Boulevard Improvements project. The estimated project cost is \$775,000 as shown below. The funding required is in the 2023 Capital Budget request in the W Main St Bike Boulevard Improvements project and the Pavement Management program. Any contract award would be contingent upon approval of the requisite funding in the 2023 Capital Budget.
