### Fiscal Note

The proposed resolution includes deleting the classification of Streets Operations Manager and creating the classification of Assistant Streets Superintendent. The cost for the remainder of 2015 is approximately \$902 (or \$1,033 including benefits) and is available in the 2015 operating budget. The projected annualized cost is \$4,788 (or \$5,480 including benefits).

### Title

Deleting the classification of Streets Operations Manager in CG 18, R14, and creating the classification of Assistant Streets Superintendent in CG 18, R15. Recreating and retitling the position #1700 of 1.0 FTE Streets Operations Manager in CG18, R14 as Assistant Streets Superintendent in CG18-15, in the Streets Division Operating Budget; and reallocating the incumbent, S. Schultz to the new position.

### Body

Resolution deleting the classification of Streets Operations Manager in CG18, R14, and creating the

classification of Assistant Streets Superintendent in CG18, R15, deleting and recreating the 1.0 FTE position #1700 of Streets Operations Manager in (CG18, Range 14), as an Assistant Streets Superintendent (CG18, Range 15) in the Streets Division budget and reallocating the incumbent (S. Schultz) to the new position thereof.
