### Fiscal Note

The proposed resolution awards the contract for Monona Bay weed cutting at a total estimated cost of \$198,680. The adopted 2017 capital budget appropriates \$220,000 to the Stormwater Utility to provide for dredging projects to keep the system functioning properly (MUNIS 10315). Funding is provided by Stormwater Utility GO Borrowing and reserves.
