Fiscal Note

The proposed resolution authorizes the Mayor and City Clerk to enter into an agreement with the US Geological Survey to monitor leaf runoff at an estimated cost of \$124,000. The City of Madison will provide \$93,000, reimbursed by the League of Wisconsin Municipalities, and the USGS will contribute \$31,000 in matching funds.

The proposed resolution also amends the 2021 Adopted Operating Budget for the Stormwater Utility. Under the proposed resolution, \$31,000 would be added to the Stormwater Utility purchased services budget. Funding is available from the League of Wisconsin Municipalities via the MOU referenced in this resolution. Expenditure and revenue budget authority will be included in the Operating Budgets of the subsequent two years of the three-year agreement.

Body

WHEREAS the City is one of many municipalities required to comply with the recently adopted Rock RiverTMDL; and

WHEREAS, WDNR staff believes that it is possible that we are not receiving sufficient credit for the leaf collections efforts that we currently undertake as they regard to the reduction in phosphorous that is achieved; and

WHEREAS, to document the enhanced levels of reduction compared to no controls a study of this nature is required as the work has not been done nationally; and

WHEREAS, initial results have be promising and expanding the study will expedite a decision by the WDNR in regards to leaf collection credits; and

WHEREAS to document the reduction compared to no controls in watersheds draining to wet detention basins, efforts a study of this nature is required; and

WHEREAS; the League of Wisconsin Municipalities have funds dedicated to support the leaf collection study;

NOW, THEREFORE, BE IT RESOLVED that the Mayor and City Clerk are authorized to enter into an agreement with the USGS to monitor storm water quality associated with a leaf collection, and to accept funding for this project from the League of Wisconsin Municipalities, and to enter in the a MOU with the League of Wisconsin Municipalities to accept fund for the leaf collection study.

BE IT FINALLY RESOLVED that the 2021 Operating Budget of Stormwater is hereby amended as outlined in the Fiscal Note.
