No appropriation required. Resolution 64268 adopted March 16, 2021 waived license and permit fees for Public Passenger Services through December 31, 2021 due to COVID-19 and other economic hardships.

Title

Approval of Taxicab Operator's License Renewals

Body

WHEREAS, pursuant to Section 11.06, Madison General Ordinances, the following firms have applied for renewals of their taxicab operator licenses and permits, effective July 1, 2021:

Affiliated Carriage Systems, Inc., dba Madison Taxi, requesting 22 taxicab meter permits and 1 airport shuttle

Badger Bus Lines, Inc., requesting 23 flat rate permits

Green Cab of Madison Incorporated, 48 zone taxicab permits

Transit Solutions, Inc., requesting 36 flat rate permits

Union Cab of Madison Cooperative, 42 meter permits

WHEREAS, the Traffic Engineer has provided the Transportation Commission with an investigative report on the applications and a recommendation to grant the licenses;

WHEREAS, the Common Council recommends that the following actions be taken with respect to the above applications for licenses:

1. Approval of the application for license to operate taxicabs by Affiliated Carriage System, Inc., dba Madison Taxi (1403 Gilson Street) for 23 taxicab meter permits.
2. Approval of the application for license to operate Transportation Service vehicles by Badger Bus Lines, Inc. (5501 Femrite Dr.) for 23 permits.
3. Approval of the application for license to operate taxicabs by Green Cab of Madison Incorporated (700 Cottage Grove Rd.) for 48 zone taxicab permits.
4. Approval of the application for license to operate Specialized Transportation Service vehicles by Transit Solutions, Inc. (416 S. Main Street, Deforest, WI 53532) for 36 permits.
6. Approval of the application for license to operate taxicabs by Union Cab of Madison Cooperative (2458 Pennsylvania Ave.) for 42 taxicab meter permits.
