PREAMBLE

The City is proposing to reconstruct State Street from Park Street to Lake Street in 2014. The consultant's services will include Preliminary Design services & the completion of Final Plans & Specifications.

Pursuant to City Ordinances and Policies, the City Engineer advertised for consultant proposals, reviewed the submitted proposals, and recommends the design engineering contract be awarded to MSA Professional Services, Inc..

The City of Madison and Dane County are participating in the design and shall cost share the design engineering contract.
