### Body

WHEREAS, The City of Madison has proposed contracting the construction inspection and oversight for the Central Park Phase 1 Construction project; and,

WHEREAS, Federal funds have been designated for the project and portions of this oversight contract are eligible for such funding; and,

WHEREAS, Pursuant to City Ordinances and Policies, the City Engineer advertised for consultant qualifications as required under the federal guidelines, reviewed the submitted qualifications, and recommends the design engineering contract for Central Park Phase 1A Construction Oversight be awarded to MSA Professional Services, Inc.

NOW THEREFORE BE IT RESOLVED, that the Mayor and City Clerk are hereby authorized to execute an agreement with MSA Professional Services, Inc. for design engineering services for Central Park Phase 1A Construction Oversight, pending the approval by WisDOT, and subject to the approval and authorization of Federal Funds by the State of Wisconsin Department of Transportation.
