**WHEREAS**, the following firms have applied for renewals of their Pedal-Cab licenses, effective July 1, 2015:

**WHEREAS**, the Traffic Engineer has provided the Transit and Parking Commission with an investigative report on the applications and a recommendation to grant the licenses;

**WHEREAS**, the Common Council recommends that the following actions be taken with respect to the above applications for licenses:

1. Approval of the application for license to operate pedal cabs by Black and Tan Bike Cab for 1 pedal-cab permits.
2. Approval of the application for license to operate pedal cabs by il Corvo Pedicab Service for 1 pedal-cab permits.
