### Title

Relating to 2015-2017 Commercial Quadricycle Licensure of Capitol Pedicyle dba Trolley Pub.

### Body

**WHEREAS**, Capitol Pedaler has a new owner and the former owner's Commercial Quadricycle license and permits are non-transferable;

**WHEREAS**, the following company has purchased the Capitol Pedaler's assets and has applied for a new Commercial Quadricycle license, effective July 1, 2015:

**Capitol Pedicyle dba Trolley Pub (formerly Capitol Pedaler)**, requesting two Commercial Quadricycle permits;

**WHEREAS**, the Traffic Engineer has provided the Transit and Parking Commission with an investigative report on the applications and a recommendation to grant the license;

**WHEREAS**, the Common Council recommends that the following actions be taken with respect to the above application for license:

Approval of the application for license to operate a Commercial Quadricycle company license by the new owner, Capitol Pedicyle dba Trolley Pub, and for two Commercial Quadricycle vehicle permits.

**NOW, THEREFORE, BE IT RESOLVED** that the following licenses are issued, subject to the provisions and

conditions as stated above and the ordinances of the City of Madison:
