### **Fiscal Note**

As stated in the Employment Agreement between the City of Madison and Gregg R. McManners, the Director's initial year's salary will be based on an annualized rate of \$126,000 and will be adjusted by the base rate increase provided to employees in CG 21. The Director shall receive the same benefits as all other non-represented professional employees in CG 18. Additionally, the Director shall be entitled to benefits including vacation and sick leave; compensation for participation in professional seminars, conferences, workshops, and related meetings; compensation for participation in community, civic, and professional activities and events; compensation for participation in relevant professional organizations; and is eligible for a smart phone with data plan for City usage.
