Overhead electrical and communication lines along N. Pinckney Street where included in the N. Pinckney Street roadway reconstruction and undergrounding project previously approved on December 4, 2015, RES-15-00922 and also RES-15-00133 approved on February 26, 2015.

Further authorization and funding approval is required to close out the project.

NOW THEREFORE BE IT RESOLVED, that the Common Council hereby authorizes the Mayor and City Clerk to execute an agreement and the Finance Director to issue a purchase order to Charter Communications for the undergrounding of overhead utilities along N. Pinckney Street.

BE IT FURTHER RESOLVED that the 2016 Capital Budget of Major Streets is hereby amended to increase budget authority in the N. Pinckney Street Project (10256) by \$35,000 funded by TID #32.
