#### **Fiscal Note**

In the adopted 2016 capital budget the Stormwater Utility has budgeted \$50,000 for work to solve drainage problems on private property throughout the City within the Backyard Drainage Problems program (MUNIS 10307). The minor projects within that program are established with sufficient budget authority for the contracted work in the proposed resolution (MUNIS 10535 and MUNIS 10973). Funding is provided by GO borrowing and Stormwater reserves.

The proposed resolution awards the contract at an estimated cost of \$43,990.
