Fiscal Note

In the adopted 2017 capital budget Engineering Major Streets has budgeted \$500,000 of GO borrowing for the Neighborhood Traffic Management and Pedestrian Improvements capital program (MUNIS 10546). The minor project within that program for traffic calming is funded in accordance with the plans in the proposed resolution at multiple locations throughout the city in 2017. Additionally, Metro Transit has budgeted \$40,000 for the pedestrian improvements at bus stops within the grounds improvement line item of the adopted 2017 operating budget.

The proposed resolution approves plan documents at an estimated cost of \$185,000.

This project consists of installation of various traffic calming and pedestrian enhancements citywide. Each specific location undergoes evaluation and separate approval processes. Upon approval, this public works contract provides means to construct the approved devices.
