The Public Health 2017 adopted capital budget includes \$765,000 for the Remodel of Office Space (Munis project #17047) funded by GO Borrowing. The proposed resolution authorizes a Purchase of Services (Architect) contract with Continuum Architects + Planners S.C. to provide professional architectural and engineering design services and construction administration services for the design and construction of the Public Health Offices Remodel in the City-County Building for an estimated cost of \$90,000. Funding is available in the project.
