### Fiscal Note

The proposed resolution establishes the North Pinckney Street Underground Utility District for planned work in 2018. The associated cost of reimbursement to eligible properties is \$1,246 which is budgeted within the minor project for East Gilman and North Pinckney Street via the Reconstruction Streets capital program as adopted in the 2017 Engineering Major Streets Capital budget.

### Title

Declaring the City of Madison's intention to exercise its police powers establishing the North Pinckney Street Underground Utility District-2018.

### Body

BE IT HEREBY RESOLVED:

1. That the Common Council of the City of Madison hereby establishes an underground utility district known as the North Pinckney Street Underground Utility District-2018 pursuant to Subsection 19.16(6) of the Madison General Ordinances. The limits of the district are E. Gilman Street to the north end.
2. That the Common Council intends to place overhead utility services underground in this District.
3. That the purpose of the undergrounding project that will occur in the District is to remove overhead lines and replace them with underground systems and services. As a part of the undergrounding project, private services need to be upgraded to accommodate the new underground service connection. One (1) property in the District is currently served overhead and is not ready to receive underground service.

4. That the properties in the District that will be affected by the undergrounding project are set forth on Exhibit A to this resolution.

5. The properties listed on Exhibit A are currently served by utilities with above ground wires and the property owners are hereby ordered to modify the property's electrical services to accept underground service within 24 months of the date of adoption of this resolution or as provided in subsection 19.16(6)(c) and 19.16(6)(d). Each Property eligible for reimbursement under Subsection 19.16(6)(e)1 shall be reimbursed by the City Engineer the 2018 reimbursement rate, an amount not to exceed \$1,246.
