### **Fiscal Note**

The proposed resolution approves plans and authorizes the Board of Public Works to advertise and receive bids for the Reindahl Restroom Remodel. The total estimated cost of the project is \$86,000. Funding is available in the 2021 Adopted Capital Budget for Park Facility Improvements (MUNIS 12789).

The Capital Budget includes funding for the Reindahl Restroom Remodel. The project funds the creation of two single use restrooms and a small mechanical room within the existing concessions space of the current mechanical building at the Reindahl Park Splash Pad, located at 1818 Portage Rd, Madison, WI.

This resolution approves the plans and specifications for the project, authorizes the Board of Public Works to advertise for and receive bids for the project, authorizes execution of any lease or easement documents necessary to accomplish the project and authorizes the acquisition of materials and services required to successfully complete the project.
