### Fiscal Note

As stated in the Employment Agreement between the City of Madison and Maribeth L. Witzel-Behl, the City Clerk's salary will be based on a total annualized rate of \$127,624 effective September 12, 2021. The City Clerk is approved and funded in the 2021 Adopted Operating Budget. Annual salary adjustments may be made during the term of the agreement at the Mayor's discretion, subject to Common Council approval.
