CLAIM FOR EXCESSIVE ASSESSMENT

Claimant Wal-Mart Real Estate Business Trust, by its attorneys Gimbel, Reilly, Guerin & Brown LLP, asserts it is the owner of parcel number 0810-334-0407-1 (the Property) located at 4198 Nakoosa Trl., Madison, Wisconsin, and files this Claim for Excessive Assessment against the City of Madison (the "City"), pursuant to WIS. STAT. § 74.37.

- Claimant is the owner of the property, located at 4198 Nakoosa Trl., Madison, Wisconsin, and is responsible for taxes on the Property and is authorized to bring this claim in its own name.
- 2. For the 2021 tax year, property in the City was assessed at 0.99275003% of its fair market value as of January 1, 2021, and was taxed at \$21.498 per \$1,000 of assessed value. A copy of the 2021 tax information is attached as Exhibit A.
- 3. For the 2021 tax year, the value of the Property was set by the City Assessor's office at \$11,920,000.
- 4. Claimant made a timely objection to the Board of Review, and the Board determined the 2021 final assessment to be \$11,920,000. A copy of the Notice of Board of Review Determination is attached as Exhibit B.
- 5. Based on this assessment, the City imposed a tax of \$256,170.36 on the Property.
- 6. The assessed value of the Property as of January 1, 2021, should be no higher than \$7,008,347. This value is derived from sales of comparable properties and by ascertaining the fair market rent for the Property and capitalizing that amount, net of vacancy and collection loss and net of expenses. Additionally, the Property was not assessed uniformly in compliance with Article VIII, Section 1 of the Wisconsin Constitution.



- 7. Based on the assessment ratio set forth in paragraph 2, the correct assessment of the Property for the 2021 assessment should be no higher than \$7,008,347, and the correct tax on the Property for 2021 should be no higher than \$150,665.44.
- 8. As a result of the excessive assessment of the Property for the 2021 tax year, an excess tax in at least the amount of \$105,590.72 was imposed on the Property.
- 9. The amount of this claim is \$105,590.72, plus interest thereon at the applicable statutory rate.
