- The <u>cost</u> to serve the area



Agencies serving expansion area

- > Fire
 - No additional cost to serve

Agencies not yet serving expansion area

- City Engineering
 - Services are available for extension
- > Streets
 - Will provide services once properties are attached to the city.
- Sanitary
 - Sewers located on Autumn Lake Parkway
 & Golden Duck Parkway and Lien Road

- Stormwater
 - New Developments required to extend public stormwater infrastructure
- Traffic Engineering
 - No additional cost to serve
- Metro Transit
 - Increased Operating Budget or cut to existing service needed to serve expansion area
- Police
 - Additional workload is .62 officers. The annualized cost of a new officer with initial issue costs is generally \$103K

Central Urban Service Area Expansion (CUSA) - Felland

Agencies not yet serving expansion area (continued)

Parks

- Lands transferred to the City of Madison will continue to be used as a park
- Operating Budget \$15,000-\$30,000 per year per park (When Town park is attached 2036)
- > Water Utility
 - Will be provided through extension of water mains within Pressure Zone 3
 - Laterals need to be extended to properties at owner's expense.

 - Residential, parks, and open space uses in the expansion area



- Entire area is in the Town of Verona

Ability to serve the CUSA expansion area

Agencies serving expansion area

None, serve land adjacent to expansion area

Agencies not yet serving expansion area

- City Engineering
 - Services are available for extension
- Streets
 - Provided by the West Side Public Works Facility
- Sanitary
 - Adjacent to expansion area and can be extended to serve area
 - Laterals need to be extended to properties at owner's expense.

Agencies not yet serving expansion area

- Stormwater
 - In Upper Badger Mill Creek (UBMC)
 - New development required to construct public stormwater infrastructure
- Traffic Engineering
 - Require city cost share on the order of \$1,000-\$1,500 per foot for arterial roadways and \$500-\$800 per foot for collector roadways
- > Metro Transit
 - Increased Operating Budget or cut to existing service needed to serve expansion area

Agencies not yet serving expansion area

Police

• additional workload is 1.67 officers. The annualized cost of a new officer with initial issue costs is generally \$103K

➢ Fire

• Estimate a need for an additional ambulance and crew to provide sufficient coverage

Parks

- \$350-\$500k per park improvement
- Operating Budget \$15,000-\$30,000 per year per park

- > Water Utility
 - Will be provided through extension of water mains within Pressure Zone 8, 9, 10
 - Laterals need to be extended to properties at owner's expense.
