We, Erin Nuñez and Rommel Tijerino, are writing to ask for your support and approval of the funding for the 0.6 FTE Community Connector – Spanish position in DCR. We have been residents of Madison for over 20 years. We currently work for the City of Madison and we are the co-leaders of the Latinx Community Engagement Team (LCET).

The Latinx Community Engagement Team was formed in 2015. We are a group of city staff, bilingual in Spanish and English, who work to support the work of city agencies to build trust and strong relationships with Spanish-speakers and members of the Latinx community.

Subject: DCR Supplemental Budget Request – Community Connector Position(s)

The Latinx Community Engagement Team (LCET) is a group of City of Madison staff bilingual in Spanish. We support the work of City agencies to increase access to services and resources and to build relationships with Spanish-speakers and members of the Latinx community who live and work in the City of Madison.

It is a stated goal of the City of Madison to be a welcoming and inclusive city for all members of the community. In 2018, the Common Council approved the [Language Access Plan](#); the Steering Committee for this plan included members of our group. This plan was long overdue, and included the goal of moving translation and interpretation internally.

Today, three years after the adoption, the City of Madison has yet to fully implement the Language Access Plan. The City currently offers basic interpretation and translation services upon request, but this model only works if both staff and the public are aware that the service is available and know how to access it. As shown in recent language phone audits conducted by the Latinx Community Engagement Team, in cooperation with the Department of Civil Rights (DCR), City of Madison agencies are not yet

providing these services consistently, although training, assistance, and resources are provided to each department.

The COVID-19 pandemic has further highlighted these service gaps. To address this need, DCR piloted new ways of providing vital information by hiring bilingual and bicultural staff members with community connections to produce written communication and videos in Mandarin (simplified Chinese) and Hmong. This pilot successfully delivered urgent messages to residents and realized cost and timesavings. With their 2021 Supplemental Budget request, DCR proposed adding three 0.6 FTE Community Connector positions, one each for Chinese, Hmong, and Spanish. The Mayor's operating budget includes the hire of a permanent, bilingual and bicultural Spanish-speaking staff member to address the need with the Spanish-speaking community. Additionally, the need for language services is expected to grow due to the upcoming attachment of the Town of Madison in 2022. Town of Madison residents are diverse; 32% of residents are non-English speakers and Spanish is one of the primary languages.

For the reasons above, the Latinx Community Engagement Team is asking you to support and approve the funding for 0.6 FTE Community Connector – Spanish position in DCR. This bilingual and bicultural position will develop two-way communication channels in residents' primary language in order to:

- Identify community needs, concerns, and priorities
- Raise awareness of existing City of Madison programs and services and multilingual resources
- Develop and produce culturally relevant content in Spanish

Hello Finance Committee members, Alders, and Mayor,

I'm writing today to say that the mayor's proposed budget is awash with misplaced priorities and corruption. The last year has seen public debates over how to solve houselessness in our community, and we've run up time and again against the constraints of the budget. But rather than taking bold budgetary action to provide the services and facilities that can hold our community together in the face of climate collapse, mass displacement, a coming wave of evictions in our community, and political turmoil around the nation, the Mayor has chosen to dump millions more into an already bloated policing budget to maintain a private standing army for the city to violently harass houseless folks trying to get by in an economy defined by shortages of affordable housing and well-paying jobs. This speaks to our priorities as a society: We would rather kick our problems down the road, letting them snowball into untenable situations that will inevitably escalate into civil unrest, than dedicate money to improving the living situation in our city. We would rather militarize and prepare to violently repress those who capitalism fails than build a city that's resilient to that turmoil, and that alleviates the suffering that causes turmoil.

Last year saw a mass uprising demanding the abolition of the institution of policing and its replacement with a system of community care that deals with antisocial behavior at its root, rather than waiting for conditions of neglect to boil over into violence. This demand was diluted by national media to a call for mere defunding of police- and I do believe that defunding the police is a workable first step towards building a society that places people first. And yet, as we slashed tens of millions off of the city's operating budget in the face of a global pandemic, we actually ***increased*** the police budget, rewarding them for their violent behavior, for continuing to ignore the murderer in their department, for escalating fully peaceful protests to the level of property damage with their militarized presence and indiscriminate use of physical and chemical weapons against civilians. And this year, as MPD continues to ignore its problems, as it [treats houseless folks staying at a shelter as prisoners, standing by as people suffer asthma attacks](#), the mayor once again wishes to reward violent behavior with millions of dollars of additional funding. MPD holds onto and protects its bad apples- and if you know anything about food preservation, you know that even one bad apple spoils the bunch. At this point, MPD is rotten to its core, and the knee-jerk reaction of throwing money at them to solve that has proven ineffective year after year.

This has gone on long enough. Defund the police, and shift that money to shelters and boarding houses for community members who've lost their homes, to urban farming projects and food pantries to feed our neighbors, to libraries and community centers and programs that interrupt antisocial behavior at its root, and to CAHOOTS and strong mental health care programs that are more equipped to manage crisis situations than armed vigilantes.

In the city of Madison adding police officers and money for the police department in the last 10+years has proven that crime rates are still going up, reporting some of the most critical ones involving youth after the pandemic started. This is a clear message that our youth and young adult members of our communities need resources and not police, spaces to thrive and have opportunities, not jails and fines that only push us backwards. Madison Police put many lives at risk that night when they did this operation without thinking of the dangerous situation and possible weapons involvement this ended up having. Businesses owners and students are still traumatized and shaken by that night.

The police we already have needs to do better and work on training and protocol when doing operations like this, they did not served or protected those who were out innocent and completely uninvolved with the suspect.

This is not the only situation that reassures why we do not need more police, we can get specific and detailed on many, but this is short but clear message to amplify the demands of our communities that are screaming for resources, safe spaces and many other priorities we see lacking in our city, not more police.

My name is Sophie Wolbert and I am a concerned, life-long resident of Madison. I am writing to express my disappointment with the 2022 budget that Mayor Rhodes-Conway and the city of Madison recently released.

The funding disparities present in this budget show Madison's priorities clear as day. It makes no sense to me that the police department would require over \$84 million (which is a \$2 million increase from the previous year) while affordable housing and public health would only receive around \$7 million each. Why are we giving the police more than 10 times the amount of money that we're giving affordable housing and public health? Also, there are environmental factors when horse manure goes into the drainage system. historically racist, environmentally disruptive practices must end.

2. They have a drone, I did not see any reason why their current one is not okay to continue use. Although unless it is being used to do things like locate sex traffickers, white supremacist terrorist groups, and missing people, I do not find the use of a surveillance drone appropriate at all.

3. the Police Unions are a relic of the KKK. They are full of white supremacists and white supremacist apologists, as in they do not care they are an organization full of bigotry. Also, I've read some of the WPPA information, it does not appear they are fully up to date on the sciences of human behavior, so they do not know how to properly do anything as they reject current science. So, even though it might look like the positions Barnes wants to add would begin to help address racism in the system, these positions would hold union contracts, making them part of the racist system. Add positions in public health, or civil rights departments. We can take good ideas that are under the umbrella term and department of "police" and take those ideas to other departments. Divest from policing and Invest in community care by doing this.

4. using the term "gang" and having gang units are not appropriate ways to address gun violence and other violence and the selling of illegal items. Gangs formed because people were poor, had no resources, and could not trust the police to help them. Further we do not need to be criminalizing people for possessing, buying or selling drugs. we need to be providing opportunities for people to get help, and providing better education and programs to our youth so they grow believing in themselves and loving themselves so they do not turn to activities to escape their problems. this style of policing "gangs" is rooted in racism, the

practices of policing were designed by active white race dominant believers, and those who didn't understand/believe that poor mental health is the cause of violent behaviors.

5. we do not need cops to address people "pandering". making it illegal to ask for money was a law that was made after Black people were free'd but given no resources, and continuously not allowed to work or live anywhere because racists made laws to keep black people in poverty then criminalized being poor.

6. Everyone reading this should publicly call for Matt Kenny to be charged with murder. it is never too late to be on the side of moral justice.

7. Ban tear gas. the proper response to property damage, or people not leaving an area the police have asked them too, is not to spray them chemicals that have been banned in war. anyone for tear gas is for something banned internationally, think about that ya'll.
