### NARRATIVE:

On Sunday, January 24, 2010 at approximately 1720 hours, I, Ofc. Dzick was on routine patrol at the corner of State St. and N. Lake St. when I observed a Madison Fire Department Engine respond to this location. The MFD had their emergency lights activated as well as their siren. When the MFD arrived, I observed them looking at the Jin's Fish and Chicken trailer was parked in the 700 block of State St., otherwise called Library Mall.

I was not dispatched to the location, so I just observed and continued on my way. At approximately 1733 hours, I was dispatched to this same location to contact a reporting party about the trailer.


When I arrived, I contacted Rosemary Lee who was standing on the west corner of the 500 block of N. Lake St. When I contacted Rosemary, she explained to me that she was on a city committee involving the vendor's trailers and this particular trailer was in violation of the city code. Rosemary explained that she called Alderman Verveer and he was responding to this location. I obtained Rosemary's information and noted the trailer's surroundings.

I observed five, unsecured propane tanks at the east end of the trailer, by the tongue of the trailer. On the north side, I noticed a wood cart near the business as well as an electrical extension cord that lead from the trailer to a nearby light standard. The extension cord was plugged into the standard. On the east side of the trailer was five, five-gallon containers of frying oil that were unsecured. I looked in the trailer and it was unattended. No time during my shift did I notice anyone around the trailer.

I noticed the trailer was still parked at the same location on January 30, 2010.

Ald. Verveer asked me to have a copy of this report forwarded to Warren Hanson of the City-Ordinance Planning Department, as well as Lana Mades and Lara Minella.

#### NARRATIVE:

On 03-29-10 at approximately 1:50 PM I spoke with Rosemary Lee while I was assigned to the Self Report Unit. Lee told me she had reviewed Officer Heather Dzick's original report and wished to have a piece of information added to it. She told me the original reason she had called the 911 center was because when she walked passed Jin's Fish and Chicken trailer, she smelled a strong odor of propane. Taking into consideration that the trailer was parked on the Library Mall, she feared if the tanks exploded there would be a large amount of people it could affect. Library Mall can be guite populous. The tanks were located near the hitch area of the trailer.
