I've lived at 5005 Ironwood Drive, Madison for many years. As a lifelong Madison resident, District 16, I appreciate the many changes the city has gone through. I appreciate the thought of the Madison Market and understand the hope for it. However. I think there are different and more important fundamental priorities that money needs to be spent on without operating at a giant deficit. As a nurse, I know Maslow's Hierarchy of needs starts with physical safety. If you insist on putting Madison further into debt, increasing resources to programs like CARES which will help people in mental health crisis—which can subsequently impact their physical safety as well as the safety of those around them—is worth supporting.
