Pollworker coordinator will not assign them to work in the specific district of interest; or in the case of a citywide candidate, will not assign them anywhere. This will be in effect only for that election and the primary. In addition, the candidates will receive a notice advising them of the policy. Similar methods can be used for elected officials, referendums, and recalls.
