Hello,

Enclosed you will find two formal protest petitions. They are each submitted under Section 28.182(5)(c) of the Madison General Ordinances. I am submitting these Protest Petitions on behalf of the nearby neighbors of Edgewood Schools. We are protesting the proposed zoning change that, if approved, would repeal Section 28.022 - 00117 of the Madison General Ordinances adopting the Campus Master Plan for Edgewood College, Edgewood High School and Edgewood Campus School.

On August 26th I submitted a petition that was appropriately rejected. I am now submitting two protest petitions: one signed by owners of land directly opposite from the subject property and extending 100 feet from the street frontage of the opposite land, and one signed by registered electors residing within buildings any part of which are on land directly opposite the subject property and extending 100 feet from the street frontage of the opposite land.

By way of explanation, during the collection of signatures for the initial protest petition we discovered that many of the residents nearby Edgewood were disappointed by the requirement of land ownership. We confirmed that protest petitions may also be submitted by eligible registered electors. Consequently, we collected signatures on two petitions: one petition for eligible property owners and one petition for eligible registered electors.

All the signatories to the first petition are eligible property owners; all signatures are notarized. Also enclosed, for your convenience, is a list of the signatories to the landowner protest petition.

All the signatories to the second petition are eligible registered electors; all signatures are notarized. Attached, for your convenience, is a list of the signatories to the registered elector protest petition.

After City staff have reviewed the petitions and determined whether they comply with applicable requirements, I would appreciate your providing me with a copy of this determination.
