5017, 5021, and 5025 Femrite Dr

The following properties proposed for demolition are part of a larger project that DuPont is initiating with the City. They are planning an expansion to their plant at 3322 Agriculture Drive. For the upcoming phase, they will demolish the buildings located at 5017, 5021, and 5025 Femrite, consolidate the lots through a CSM process, and begin site work to prepare the property for the plant expansion.

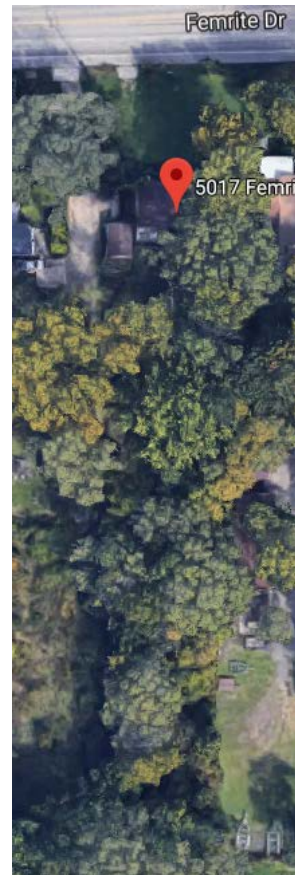


5017 Femrite Dr

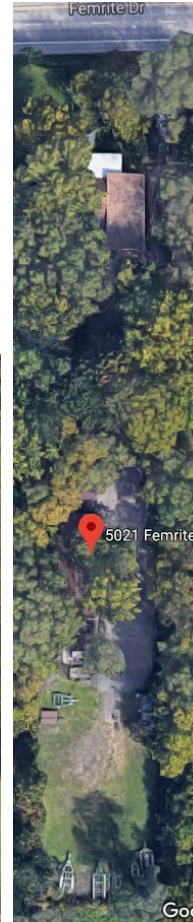
