3. 50983 Temporary Class B Retailer License Concurrent with Street Use Permit Verona Wildcats Youth Hockey Association Event Location: 931 E Main Street Event Date: October 13, 2018 Aldermanic District 6 (Ald. Rummel) Police District: 408 Event: The Humdinger

I don't support this temporary license. City staff raised questions about the route at the last Parks Commission meeting because the organizers proposed closing Ingersoll which would have impacted Metro. I have not been informed of any changes to the route. In addition, I am struggling with the balance between the sponsor and the activities of the race - one stop includes drinking 16 oz of beer or a non-alcoholic beverage. The event is sponsored by a youth sports team, from Verona. Given the conversation with the Street Use Staff Team and the community about downtown/city events, I can't support this event.

I held a neighborhood meeting on Monday to get input on this proposal. Nearby neighbors liked the idea of the brewery and having a restaurant. They plan to serve full menu until 9 but would have a late night menu. I want to make sure they have food all hours they are open. The applicants propose to stay open to midnight most of the time, due in part to state regulations. They may request later hours for special events. They would like outdoor seating. I would like clarification that the outdoor capacity is not in addition to the indoor capacity, I support 120 total and would ask the applicant to prepare a site plan for the outside when it goes to Plan Commission to determine the appropriate capacity. The outdoor seating is between two buildings and I am concerned about noise reverberation.
