Update on Zoning Code Rewrite Process - Rick Roll, Planner, Comprehensive Planning & Development Review Section

Rick Roll was present to provide an update on the City's draft zoning map open houses scheduled for September and October, 2011. He provided a draft of the Zoning Map Open Houses dates/locations and asked members for input. Ald. Shiva Bidar-Sielaff requested that Mr. Roll investigate using the UW's Engineering building or the Health Sciences Library vs. Memorial Union as a location. He noted that the zoning text has been adopted but won't be in effect until the zoning maps are adopted (tentatively spring 2012). Mr. Roll noted that at the open houses the district maps will show existing and proposed zoning

so people can see the changes. Downtown zoning text and maps are still being drafted and an open house for the downtown plan will be held later.

There will be an online comment form for people to fill out as well, detailed maps will be available at the open houses and many other opportunities for the public to comment (e.g. Plan Commission public hearings). Ald. Lauren Cnare requested that the amendment process for the maps be facilitated/conducted similar to the process used for the zoning code ordinance.
