The subject resolution would vacate or discontinue Moulton Court for a redevelopment project in the near east side of Madison. As noted in the resolution, the subject street vacation has been coordinated with the redevelopment project and right-of-way has been coordinated with current and future reconstruction needs of all adjacent public streets and public interests in this area. The developer has bought several parcels in the area so that several properties have been consolidated under one ownership; therefore, mitigating the need for Moulton Court.
