

NARRATIVE:

On 03/21/09, while on routine foot patrol with PO J McDermott, I saw Okafo at his street vending trailer, JIN's Chicken and Fish in the 300 block of W Gilman Street. I did have contact with a Dane County Sheriff Deputy on 3/18/09 who was attempting to locate Okafo to serve legal papers to him regarding proceedings involving the State of Wisconsin Department of Revenue. I did tell the Deputy that when I saw Okafo, I would notify the Sheriff's Office so the papers could be served.

I did notify the DCSO and stood by until Deputy Zeitsch arrived. We did try to contact Okafo at the cart but only found Kipila there at about 1:40 AM. She stated she did live with Okafo and I know from prior contact with her that Kipila is Okafo's girlfriend.

Kipila said Okafo had just spoken with her via cell phone and was due back at the cart within a few minutes. We waited for approximately ten minutes but Okafo did not return. Kipila also tried calling him but she told us Okafo was not answering the phone.

I did have a citation to issue to Okafo for Vending While Suspended for a violation I witnessed on 3/5/09 at approximately 2:00 AM. As Kipila is Okafo's girlfriend and lives with him, and that she stated she would give Okafo any paperwork for him, I did explain and serve Okafo's citation to her. Please see citation # A063547 for further information. Deputy Zeitsch did not serve the paperwork to Okafo at that time.

NARRATIVE:

On 3/5/09, at approximately 2:00 AM, PO D Hamilton and I were on routine foot patrol on the east side of the 400 block of North Frances Street. We were walking southbound from the cul-de-sac near the University Inn and I saw that JIN's Chicken and Fish vending cart was in operation. The customer service window was up and I saw there were several people in line at the cart.

As I passed the cart. I looked inside the customer window and saw the owner of the cart. Okafo. inside the cart. He was wearing poly-vinyl service gloves and I saw him handing a sandwich to a customer who was waiting in line. This is in violation of MGO 9.13(8)(d), Vending With Suspended License.

I know from professional knowledge and through consultation with the City Attorney's Office that Okafo's vending license is suspended until 3/9/09 at 11:59 PM. As a result of his license suspension. Okafo cannot serve customers or actively participate in the operation of the cart.

I did speak to PO M Goodchild who told me he also saw Okafo at the cart at approximately 3:00 to 3:30 AM on 3/5/09. PO Goodchild said he observed Okafo standing at the door of the cart directing workers. PO Goodchild said Okafo saw him approaching in his marked squad car and Okafo then walked to his pickup truck parked to the north of the cart and got in.

PO Goodchild said that when he drove by Okafo's truck, he saw Okafo sitting in the driver's seat and it appeared to PO Goodchild that Okafo was pretending to be asleep while peeking out of his nearly closed eyes.
