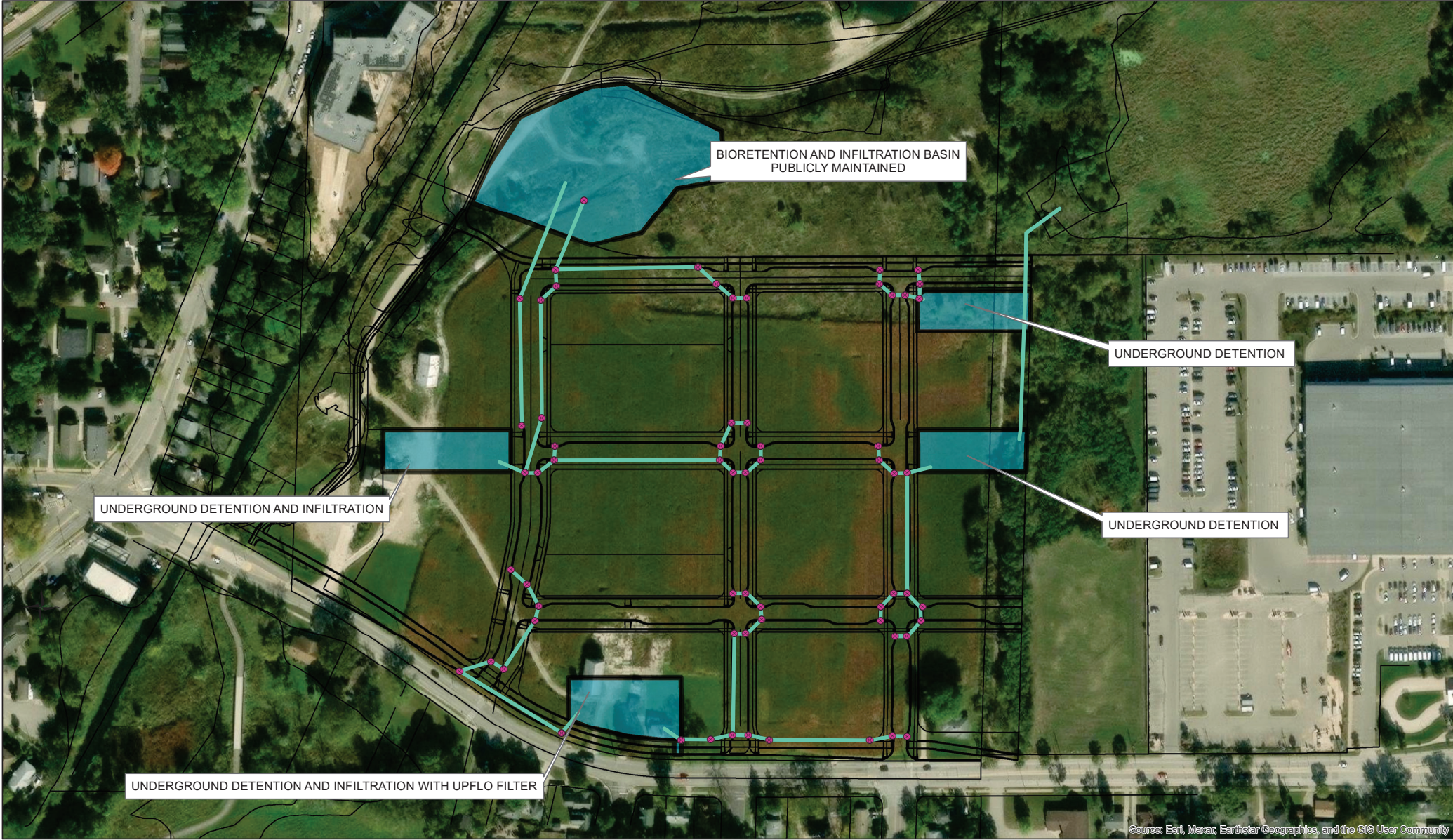

Starkweather Storm Sewer Layout and Treatment Areas 6/26/2025

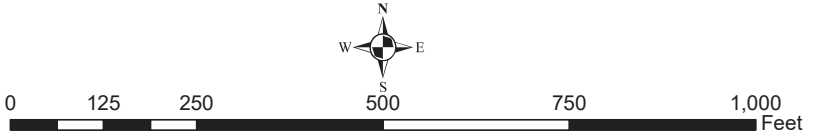

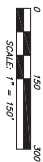

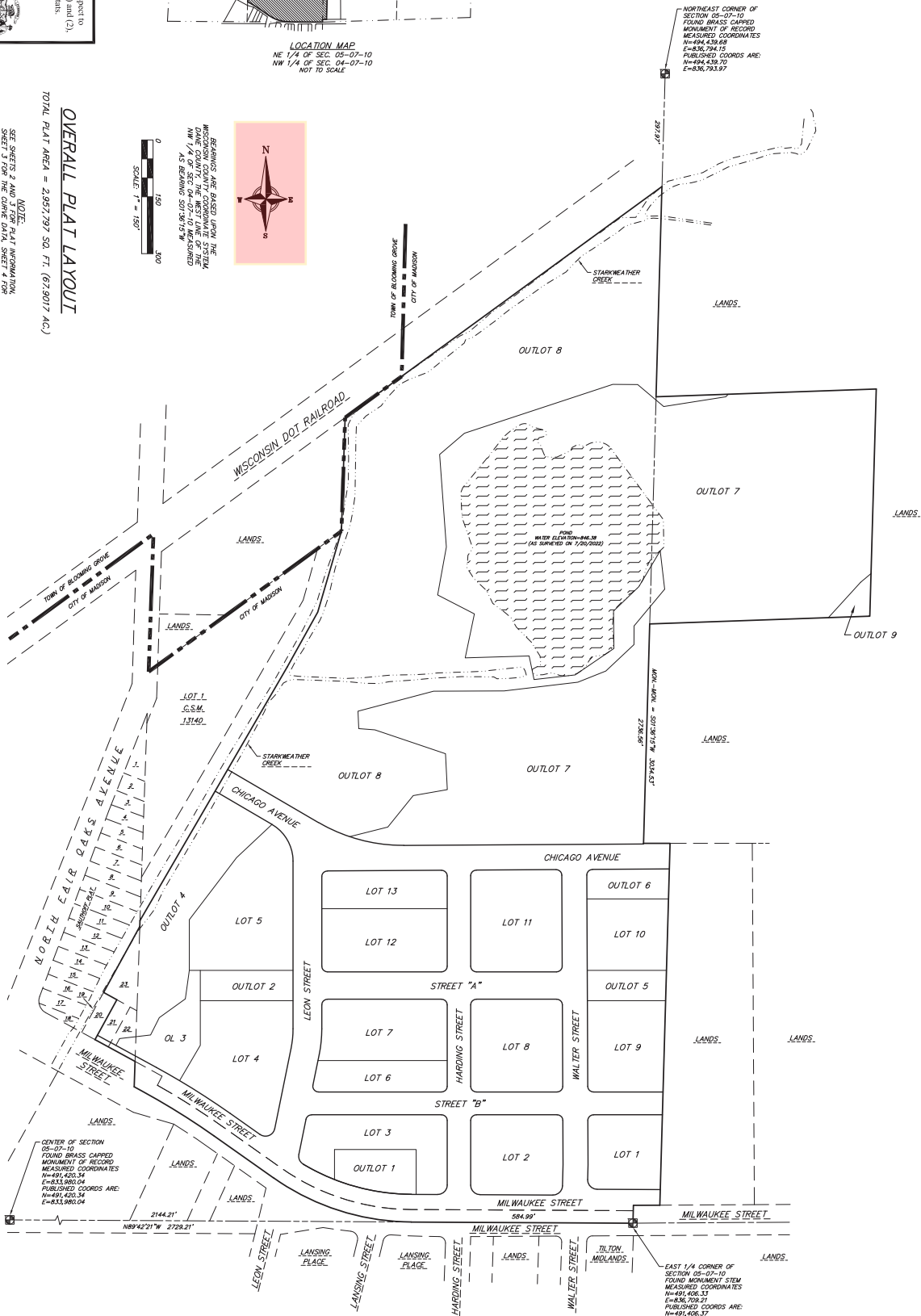

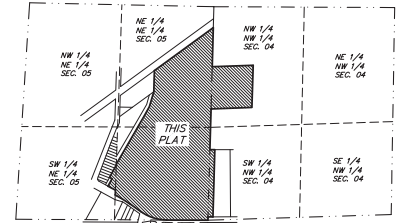

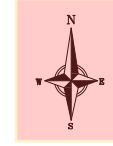

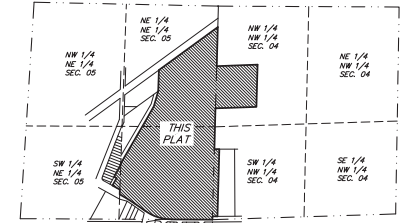

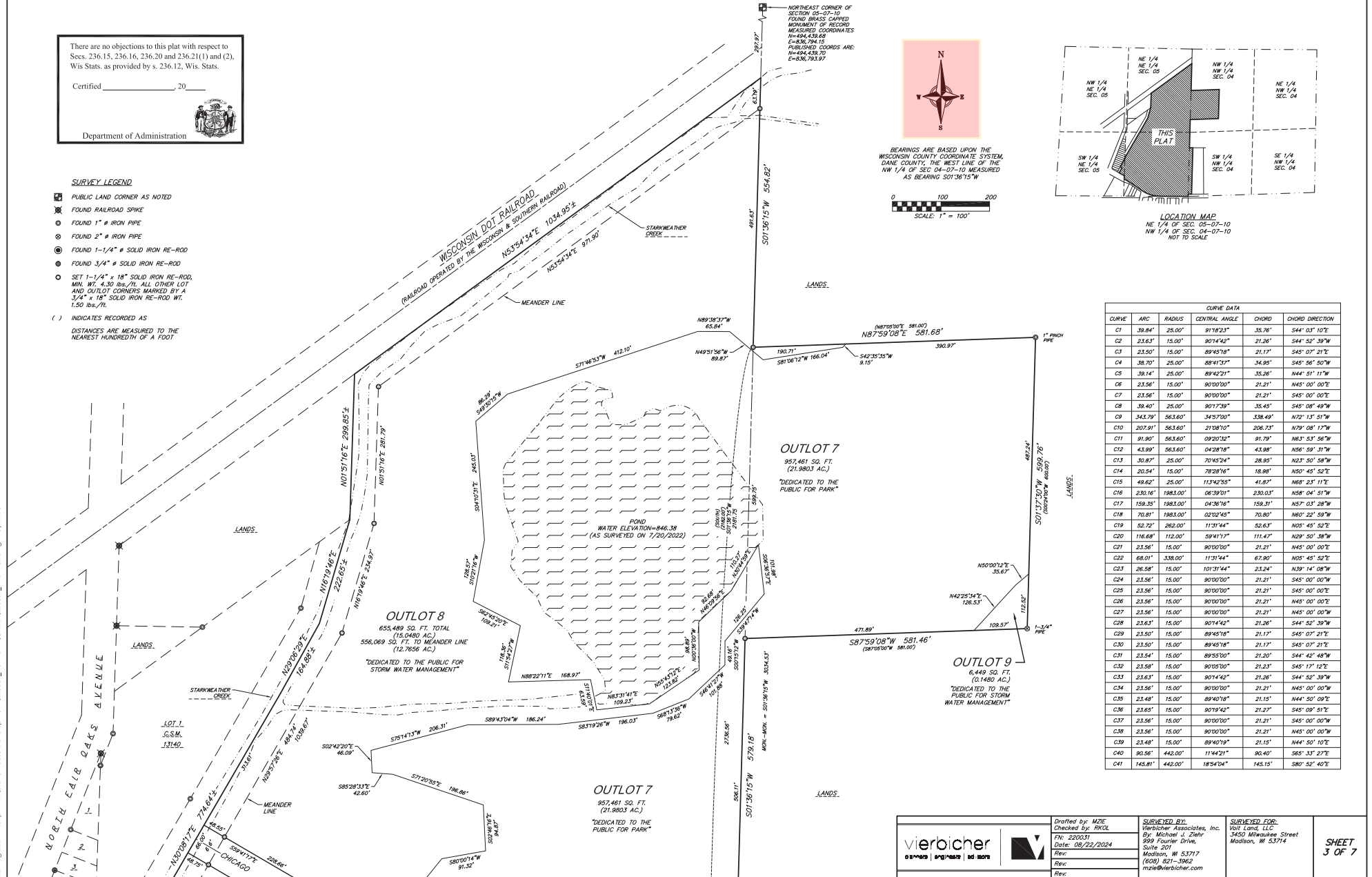
