Hello transportation commission members,

I am writing to express my perspective about the Sauk Creek greenspace that is part of the West Area Plan being discussed this evening.

I am concerned that this topic has turned into a misplaced argument between neighborhood residents and some City of Madison bike advocates.

I think one misperception has been around how residents view this space. For the Sauk Creek neighborhood, the Sauk Creek greenspace is at the heart and center of our neighborhood. It isn't a space that is perceived as dividing residents of Sauk Creek or the larger network of neighborhoods. Instead this natural area is valued for its existence as a haven for tree cover, native plants, and wildlife, an urban oasis in the midst of the built environments that surround it.

I think consensus exists that it is necessary for the city engineers to address water flow and erosion issues. Ecological restoration work is also needed as city greenspaces have never been managed by the city for ecological health or ecological diversity.

Dear Commissioners.

I urge you to maintain the East-West bike path in the Sauk Creek Greenway as part of the West Area Plan and to add back the North-South Bike Path in the Sauk Creek Greenway.

The East-West path could be part of a low stress east-west corridor through the neighborhood that could link with a proposed overpass of the Beltline. The overpass of the Beltline has been on the Transportation Improvement Plan for ~25 years and is something for which I have advocated almost as long. Having the East-West corridor mapped out could help the overpass of the Beltline score higher so that it can be built sooner rather than later.

A low stress East-West corridor between Old Sauk Road and Mineral Point Road is needed because Old Sauk and Mineral Point Roads are not low stress routes even taking into account when the widened sidewalk is completed on Mineral Point Road. I personally commuted to my job West of the Beltline on Old Sauk Road for two years. I am an avid cyclist who would be classified as a type A (assertive) cyclist, but even for me Old Sauk Road could be challenging. The interchange with the Beltline was particularly challenging with all of the ramps and a substandard width bike lane under the Beltline. A lower stress route with an overpass of the Beltline would have been heartily welcomed, especially, in inclement weather.

Contrary to what has been said about the proposed North-South path, it is not a path to nowhere. It would connect Old Sauk Road to Randolph Drive which connects to Mineral Point Road providing a lower stress route than anything in the neighborhood between Old Sauk and Mineral Point Roads.

It is my understanding that there will be a North-South path through the greenway no matter what because the City needs access to the greenway for maintenance work. The only question is whether the path will be paved as a multi-use path or left as a gravel road for maintenance work. People think a gravel path will have more water infiltration than a paved path but this is not true. Packed gravel paths are about as impervious as pavement but they require much more maintenance than paved paths. If you doubt, this ask the UW about the erosion problems with the Temin Path and the DNR about the erosion problems with the Military Ridge Trail. By contrast, I have never seen a washout of the SW Path.

It is also my understanding that the tree loss would not be driven by the North-South path if it were to be built. Most of the trees are being removed because they are in bad condition or are invasive species. Removing invasive species will actually benefit the greenway.

But the real losers if the North-South path is not built will be the neighbors of the greenway. A paved path and a greenway are not mutually incompatible. To those who doubt this, I suggest you look at the SW Path. This path goes through wooded areas and areas that have been restored with prairie plants. My wife and I have been instrumental in those efforts,

planting native plants on the section from Midvale Blvd. to the Beltline overpass. The explosion of wild flowers through the year, particularly, in the fall are spectacular. It brings people to the path to see the Monarch butterflies that often make this section a stop on their migration in the fall and you often find Bird watchers on the path.

My advice is build both the East-West and North-South Paths and then be prepared to roll up your sleeves to help replant native plantings. I would suggest an Oak Savanna habitat.

Dear Transportation Committee Members, and Madison Alders:

Please support bicycle / pedestrian paths, especially those connecting existing bike routes, and to give alternatives to existing high traffic roads. I have been an avid bicyclist for more than 50 years in Madison, and have seen the benefit to the improved bicycle routes first hand.

I also lead and participate in three different bicycling groups made up of retired men and women, most of us over 65, and even some 80 years old and more. We regularly ride on Madison bike paths, as well as those in Middleton, Verona, McFarland, Waunakee, Sun Prairie, Sauk City, and Janesville. Many of the older bicyclists are not comfortable traveling in traffic and on unprotected bicycle lanes. Some of our members live at Oakwood, and many of us bicycle on Mineral Point Road, High Point Road, Old Sauk Road, and other busy streets for short stretches to get between bicycle paths. Please support a bicycle path through the Sauk Creek area, and to bypass Fish Hatchery Road, traveling from Wingra trail to the Cannonball Trail. Connecting the existing paths and adding new ones will make it so much safer for not only bicyclists, but also pedestrians, people with physical disabilities, and parents with small children to travel.

I know you have heard from people concerned about the parks, greenways, trees in the areas suggested for paths. I sympathize with people who are worried about the effect of the changes on their private land, or local parks. 


