hosting DJ music for an indefinite period.

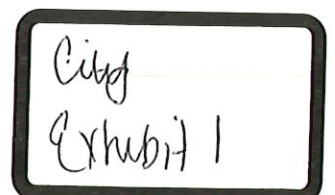
Rest assured our doors are still open. We're still
