



County Budget Challenge

- County has their own structural deficit they need to address
- AEC is increasing revenue and cutting expenses resulting in a \$1M reduction in GRP
- County funds the AEC Event Incentive Fund of \$75K through General Purpose Revenue
- As competition gets stronger County can't be expected to fund such a large percentage of discounts and maintain our facilities at a high level



2026 REQUEST

- Request to increase share of tax from current level of approximately \$90k to \$400k or all Hotel/Motel Tax collected at Spark by Hilton, Home2 Suites Alliant Energy Center, Madison Marriott South, Holiday Inn Express & Suites Madison Central and Fairfield Inn & Suites Madison South whichever is less.
- These funds will be used to attract and retain business to the Alliant Energy Center campus
- This will ensure that the campus remains healthy and continues to produce a positive economic impact for our community



JUSTIFICATION

- Alliant Energy Center events contribute produce a positive economic impact on City of Madison and Dane County
- The funds will be used to attract and retain tourism related events to the Alliant Energy Center campus.
- These events generate a positive economic impact for the City of Madison and Dane County.
- The events listed above are only a fraction of the events hosted by the Alliant Energy Center that generate hotel room night stays.
- Events not listed include the World Dairy Expo, Midwest Horse Fair, GameHole Con, WI Fishing Expo, Renaissance Dog Show, and many others.
