## EXHIBIT A

### LEGAL DESCRIPTION OF TERRITORY TO BE ATTACHED TO THE CITY OF MADISON

A parcel of land located in the Northwest 1/4 of the Northeast 1/4 of Section 20, Township 7 North, Range 8 East, presently in the Town of Middleton, Dane County, Wisconsin, being bounded on the North by the North line of said Northeast 1/4, on the East by unplatted lands owned by others and previously attached to the City of Madison by City of Madison Ordinance ORD-08-00015, on the South by unplatted lands owned by others, and on the West by the West line of said Northeast 1/4, said parcel of land described in particular as follows:

Beginning at the North 1/4 corner of said Section 20; Thence North 89°40'26" East along said North line of the Northeast 1/4 1253.02 feet to the boundary of said lands that were attached to the City of Madison (recorded in Warranty Deed, Document No. 3267312 in the Office of the Dane County Register of Deeds as NORTH 89 DEGREES 16'50" EAST, 1253.02 FEET); Thence South 1°27'12" West along said boundary, 592.78 feet (recorded in said Document as SOUTH 01 DEGREES 03'36" WEST, 592.78 FEET); Thence South 89°40'26" West, 1254.68 feet to the West line of said Northeast 1/4 (recorded as SOUTH 89 DEGREES 16'50" WEST, 1253.02 FEET); Thence North 1°36'49" East along said West line, 592.83 feet to the point of beginning (recorded as NORTH 01 DEGREES 03'36" EAST, 592.78 FEET).

Subject to the rights of the public over the North and West sides of the above described parcel for that portion thereof lying within the right-of-way of Old Sauk Road and Pioneer Road.

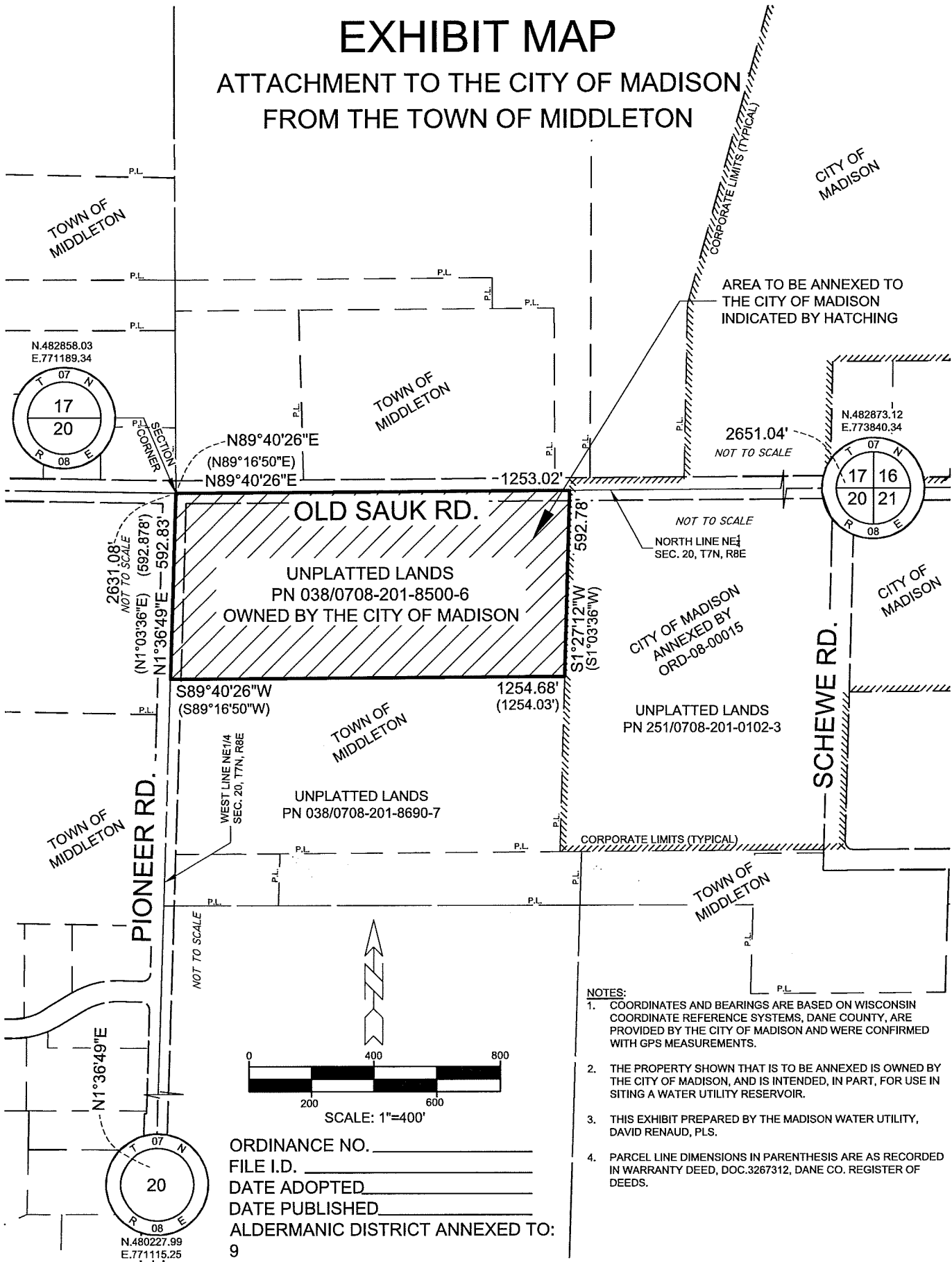
The above described parcel of land contains 742,899 square feet, or 17.05 acres or 0.0266 square miles, more or less.
