Entertainment will focus on creating a relaxed, lounge-style environment rather than a nightclub atmosphere Number of security personnel and how they will be utilized: No formal security staff will be employed. The owner and management team will be present during operating hours to monitor the premises and address any issues directly Description of clothing to identify security personnel: No dedicated security personnel Plan to handle control and clearance of the parking lot during hours of operation and at closing time: Staff and management will monitor quest departure to ensure noise is kept to a minimum and that guests exit. How will the entrance line be managed and controlled: _ Given the bar's capacity and focus on a relaxed atmosphere, lines are not anticipated. Plan for unruly patrons, intoxicated patrons, and physical disturbances: _ Staff are trained to recognize signs of intoxication and will stop service to intoxicated guests. Management will intervene in any disturbances and, if necessary, contact local law enforcement for assistance. Underage drinking and fake ID plan: All guests will be carded at the bar before service. Plan to control and supervise patrons under twenty-one (21) years of age: _ Patrons under 21 will not be admitted during standard operating hours. How will orderly appearance and operation of the premises be maintained in regard to litter and noise: Staff will check the sidewalk and surrounding areas for litter throughout the evening and after closing Sound will remain at levels appropriate for conversation, ensuring noise does not disturb neighboring properties.
