Air Walls and Track systems were installed during the original construction of Monona Terrace, as well as in 2019 during the first phase of the Air Wall and Track replacement project. Air Wall and Track systems are not interchangable between manufacturers. There is some remaining Hufcor, Inc. Track that will not need replacement however only Hufcor, Inc Air Walls will work on those Tracks. Going with another manufacturer would mean replacing both Track and Air Wall and be a considerably higher expense. Having only one system in
the building is more efficient for parts stocking and repair calls and more cost effective for staff to work on and to reconfigure rooms.
COMMENTS REGARDING PURCHASES OVER \$50,000
Hufcor, Inc. is not yet a vendor for the City of Madison. Work that was done on the Air Wall and Track systems in 2019 was done through JWC, an organization that is authorized by Hufcor to do repairs and sell parts only, but not installations. This new installation work will be performed by Hufcor.
