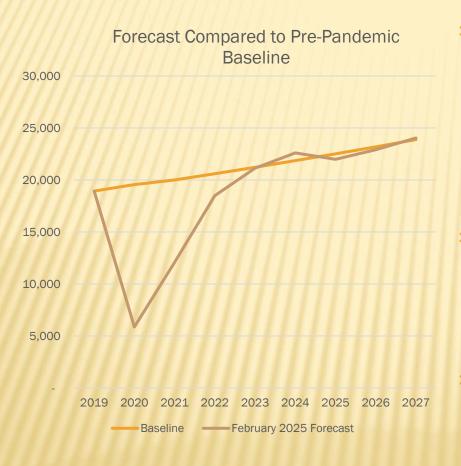

2024 BETTER THAN PREVIOUSLY FORECAST DUE PRIMARILY TO ONE-TIME REVENUES



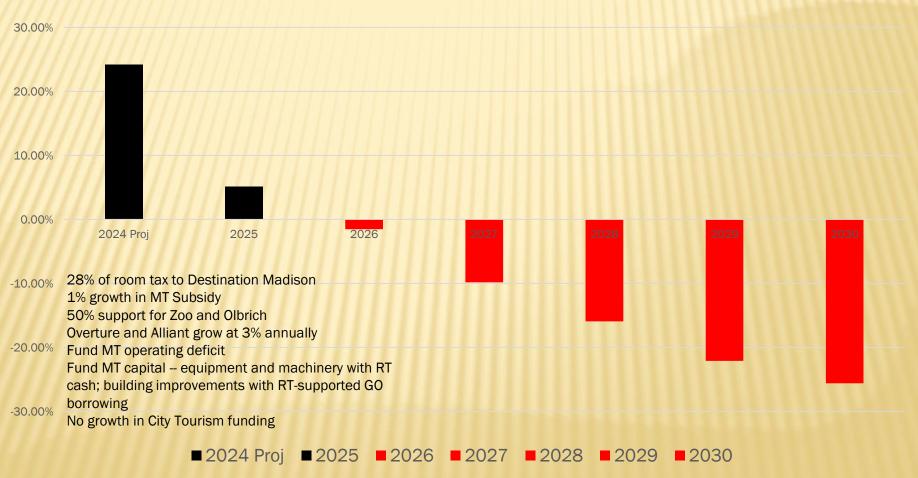
- 2024 Actual -- \$22.6 m vs. \$21.2m in August (used for 2025 budget) -- includes Q3 \$1.1 million one-time prior year payment reported at Dec. 2024 RTC meeting.
- * 4th quarter collections up 9% from 2023; Y-over-Y up 7%; [6.6% / 3.2% excluding one-time payment]
- 2025 forecast -- \$22.0m vs. \$21.8m in August (used for 2025 allocations)
