

Dear Sir/Madam,

The Community Development Division has recommended a cut to NewBridge's budget by 44% -\$277,970. If enacted, these cuts would lead to over 3,500 older adults served by NewBridge losing access to the services they need to live independently. These substantial cuts included in the Community Development Division's Older Adults Services Funding Recommendations would:

• Completely eliminate City of Madison funding for the Older Adult Program

\$138,887. This program serves over 2,000 (16,000 duplicated) older adults annually and provides opportunities for community connection, health education, exercise classes, health screenings and clinics to avoid disease, and recreational and intergenerational activities to reduce social isolation.

• Reduce critical case management services funding by \$102,000, which will result in the elimination of 1.5 case management staff and lead to the return of an 8-10 week case management waiting list. This means 80-100 older adults will be waiting for services that include - housing/homelessness, home chores, benefit applications, food insecurity, and transportation.

• Reduce home chore funding by \$20,563, which will likely lead to the elimination of 0.4 staff that recruits volunteers who provide basic household chores for 378 older adults - 35% of whom are from marginalized and BIPOC

communities. This program already carries a waitlist of 8-12 weeks with 50 older adults, which will only grow with these cuts.

• Completely eliminates City of Madison funding for volunteer guardian services \$16,125. This will lead to NewBridge suspending volunteer guardian services in the City of Madison, impacting 33 older adults who will no longer have a volunteer to assist them with critical financial and medical decisions.

While NewBridge is being cut by \$277,970, the city has proposed providing a total of \$388,039 to eight organizations that have not previously been funded. NewBridge supports funding new older adult services programming but believes the city should add more funding to the older adult services budget instead of cutting existing organizations.

NewBridge has been instrumental in providing me with services and information, allowing me to lead a productive and independent life at 76 years old. The cuts in services would be catastrophic to me and the thousands of others relying on their services. I strongly advise you NOT to make cuts to the NewBridge budget. It will cost the city far more in expenses in the long run if people like myself cannot receive assistance from NewBridge.



My name is Bonnie Rothenberg. I am 76 years old and have been a client at NewBridge for almost four year now. I have benefited greatly from my case worker Susan Watson at NewBridge. She informed me of various services and grants, helped to fill out applications where needed and submitted forms for me. As a result I received a Section 8 Choice Voucher and a grant from the Independent Living Support Pilot Program from which I received a gym membership and a motility vehicle. Without Susan I would have not known about NewBridge's services or these grants which have been life changing.

NewBridge currently serves 3,500 older adults in the City of Madison. This includes a case management program that provides 1,100 older adults with the support needed to live independently by identifying resources and coordinating services related to housing, home chore, public benefits, food insecurity, and transportation. Support provided through case management can be as serious as securing housing for an older adult who is about to be evicted or helping them apply for energy assistance to keep their electricity on or Home Delivered Meals to make sure they get proper nutrition. NewBridge also assists with basic household chores to 378 older adults - 35% are BIPOC - through its home chore program, which already carries a waitlist of 8-12 weeks with 50 older adults, and assistance with critical financial and medical decisions to 33 older adults through its volunteer guardianship program.

If enacted, the proposed funding cut will likely lead to the return of the 8-10 week waitlist or case management services, a reduction in home chore staff right as we enter the winter season, and the potential end of volunteer guardianship program services to City of Madison residents.

It is my understanding that NewBridge's budget is being cut to provide funding to eight additional organizations. If the City wishes to expand older adult services, they need to provide additional funding in the budget instead of cutting funding from one organization.

NewBridge has been serving older adults in Madison for nearly 50 years and has a proven track record. Please oppose the proposed cuts to NewBridge's budget.



Dear Sir/Madam,

The Community Development Division has recommended a cut to NewBridge's budget by 44% -\$277,970. If enacted, these cuts would lead to over 3,500 older adults served by NewBridge losing access to the services they need to live independently. These substantial cuts included in the Community Development Division's Older Adults Services Funding Recommendations would:

• Completely eliminate City of Madison funding for the Older Adult Program

\$138,887. This program serves over 2,000 (16,000 duplicated) older adults annually and provides opportunities for community connection, health education, exercise classes, health screenings and clinics to avoid disease, and recreational and intergenerational activities to reduce social isolation.

• Reduce critical case management services funding by \$102,000, which will result in the elimination of 1.5 case management staff and lead to the return of an 8-10 week case management waiting list. This means 80-100 older adults will be waiting for services that include - housing/homelessness, home chores, benefit applications, food insecurity, and transportation.

• Reduce home chore funding by \$20,563, which will likely lead to the elimination of 0.4 staff that recruits volunteers who provide basic household chores for 378 older adults - 35% of whom are from marginalized and BIPOC

communities. This program already carries a waitlist of 8-12 weeks with 50 older adults, which will only grow with these cuts.

• Completely eliminates City of Madison funding for volunteer guardian services \$16,125. This will lead to NewBridge suspending volunteer guardian services in the City of Madison, impacting 33 older adults who will no longer have a volunteer to assist them with critical financial and medical decisions.

While NewBridge is being cut by \$277,970, the city has proposed providing a total of \$388,039 to eight organizations that have not previously been funded. NewBridge supports funding new older adult services programming but believes the city should add more funding to the older adult services budget instead of cutting existing organizations.

NewBridge has been instrumental in providing me with services and information, allowing me to lead a productive and independent life at 76 years old. The cuts in services would be catastrophic to me and the thousands of others relying on their services. I strongly advise you NOT to make cuts to the NewBridge budget. 

Older Adult Services Funding Recommendation Considerations

The criteria for funding recommendations is outlined throughout the RFP as well as in other supplemental documents including the Application Instructions and the Evaluation Scoring Rubric. All of these documents were provided to applicants via CDD's funding website and highlighted during the required applicant workshops that they attended. In addition, CDD's commitment to include factors beyond application scores is described in the Forward Community Investment Funding Process Study Report, and EQT by Designs final report which was shared widely also made available on the CDD website. The following is a list of criteria taking into consideration for funding recommendations.



Target population

Programs and services focus on low-income residents, women and those that are Black, indigenous, people of color, immigrants and/or individuals who identify as LGBTQ+. This criteria also includes organizations being connected to or having a history of working with these populations. This criteria applies across the group of applications, rather than just the score or information regarding target population identified in a single application, as CDD seeks to fund programs that have a specific focus on one or more of these identified populations.

Partnerships, Collaborations and Coordination

This criteria centers around the City's efforts to build a comprehensive older adult support system amongst service providers and other key stakeholders. Partner linkage is critical and recommendations are based upon applicants having existing partnerships or having at least initiated the process of building relationships.



Location of service area – Equity Priority Areas

One of the challenges that many older adults face in accessing services is the lack of mobility. Recommendations include those that demonstrate connections to specific communities and/or geographic areas, herein referred to as "Equity Priority Areas", in which there are high concentrations of Black, Indigenous, People of Color (BIPOC), and low-income older adults. This information and specific neighborhoods are listed on page 12 of the RFP. An agency does not need to reside within an equity priority area; however, the recommended applicants addressed any programing, pertinent relationships and/or partnerships with existing agencies within or near these identified areas.

Program Need

Recommended programs are prioritized based on their ability to address critical gaps in services for older adults within the community. This includes a focus on areas where services are currently lacking or underserved, particularly for marginalized populations such as low-income older adults, and LGBTQIA+ & BIPOC communities. Proposals demonstrated a clear understanding of the community context and provided data to substantiate the need for their services were given priority consideration.

CDD's recommendations include funds for 13 of the 15 agencies that applied for funding, 7 of which would be new to CDD's older adult services portfolio.

Strength of the proposal

Based on the proposal criteria table, which was outlined in the RFP on page 14, and the Evaluation Scoring Rubric. Proposal score was not the determining factor, nor was it written anywhere in the RFP materials that funding would be awarded solely based on scores.

EQT by Design - Social Justice and Racial Equity & Older Adult Services

EQT by Design brought forth a comprehensive set of findings and recommendations which outlined targeted areas for improvement in the City's approach to determining recommendations within the older adult services funding cycle.

1. Culturally Relevant Programming

Advocate for the investment and expansion of programming and services that are culturally relevant to the BIPOC and LGBTQIA+ communities.

2. Staff Diversity

Prioritize efforts to diversify City and program staff, ensuring representation that better reflects the demographics of the communities served.

3. Support Providers Serving BIPOC/LGBTQ+

Of the 7 recommended agencies new to older adult services funding, 5 are led by and serving people of color and other marginalized populations.



Provide support to service providers catering to BIPOC and LGBTQ+ communities, recognizing the unique challenges faced by these groups.

4. Transportation Challenges

Collaborate with relevant stakeholders to help address transportation challenges faced by older adults, emphasizing the importance of a coordinated and comprehensive approach.

5. Language Access

Invest in language access design and resources to ensure that language is not a barrier for older adults in accessing services.

6. LGBTQIA+ Services

Commit to continuous learning and growth in providing services that are inclusive and sensitive to the needs of the LGBTQIA+ community.

7. Information Distribution Networks

Improve information distribution networks to older adults, ensuring that vital information reaches them through accessible and effective channels.

CDD's recommendations include funding 14 of the 15 agencies that applied for funding, 8 of which would be new to CDD's older adult services portfolio, and of which, 5 are led by and serving people of color and other marginalized populations.

Case Management Services:

Case managers serve as advocates, assisting clients in accessing essential resources and coordinating various aspects of their care. Case management Services not only meet immediate needs but also foster long-term stability and empowerment for those facing challenges in our community.

Funding Recommendations

After reviewing program proposals, applicable data, and priority areas while centering equity, reviewers summarized, and proposed funding recommendations as follows:

Experience in case management: Established experience in providing case management and addressing the unique needs of older adults

Community focus: Deep roots in serving the older adult population, with a specific focus on the Bayview community

Alignment with RFP: Strong alignment with RFP requirements, indicating a clear understanding of the needs of older adults



Detailed and effective proposal: Well-structured and organized program design, demonstrating effective planning and execution of services

I started out by attending bingo at Rhythm And Booms (fireworks at Warner Park). I make a point of treating everyone fairly.

If the funding situation requires it, I would be happy to contribute financially to an activity. I am a New Bridge member.

The activities that I enjoy on a weekly basis are Drum Circle, Chair Yoga, lunches with friends, bilingual bingo and calling bingo. Euchre via Trickstercards is from New Bridge. This has been my life since the 1990s. I purchased my home on N. Fair Oaks in 1993.

In addition, I am visually impaired and I am Caucasian. All of my life but especially at New Bridge, I have many friends of color Hispanic, Black, Japanese, and other. I am very socially conscious. I have no time for criticism either racially or other. A friend assists me with calling bingo. I call the balls and the friend puts the balls on the ball tray. The bingo players like me calling even with assistance. People are accepting and thank me.

Older Adult Services Funding Recommendation Considerations

The criteria for funding recommendations is outlined throughout the RFP as well as in other supplemental documents including the Application Instructions and the Evaluation Scoring Rubric. All of these documents were provided to applicants via CDD's funding website and highlighted during the required applicant workshops that they attended. In addition, CDD's commitment to include factors beyond application scores is described in the Forward Community Investment Funding Process Study Report, and EQT by Designs final report which was shared widely also made available on the CDD website. The following is a list of criteria taking into consideration for funding recommendations.



Target population

Programs and services focus on low-income residents, women and those that are Black, indigenous, people of color, immigrants and/or individuals who identify as LGBTQ+. This criteria also includes organizations being connected to or having a history of working with these populations. This criteria applies across the group of applications, rather than just the score or information regarding target population identified in a single application, as CDD seeks to fund programs that have a specific focus on one or more of these identified populations.

Partnerships, Collaborations and Coordination

This criteria centers around the City's efforts to build a comprehensive older adult support system amongst service providers and other key stakeholders. Partner linkage is critical and recommendations are based upon applicants having existing partnerships or having at least initiated the process of building relationships.



Location of service area – Equity Priority Areas

One of the challenges that many older adults face in accessing services is the lack of mobility. Recommendations include those that demonstrate connections to specific communities and/or geographic areas, herein referred to as "Equity Priority Areas", in which there are high concentrations of Black, Indigenous, People of Color (BIPOC), and low-income older adults. This information and specific neighborhoods are listed on page 12 of the RFP. An agency does not need to reside within an equity priority area; however, the recommended applicants addressed any programing, pertinent relationships and/or partnerships with existing agencies within or near these identified areas.

Program Need

Recommended programs are prioritized based on their ability to address critical gaps in services for older adults within the community. This includes a focus on areas where services are currently lacking or underserved, particularly for marginalized populations such as low-income older adults, and LGBTQIA+ & BIPOC communities. Proposals demonstrated a clear understanding of the community context and provided data to substantiate the need for their services were given priority consideration.

CDD's recommendations include funds for 13 of the 15 agencies that applied for funding, 7 of which would be new to CDD's older adult services portfolio.

Strength of the proposal

Based on the proposal criteria table, which was outlined in the RFP on page 14, and the Evaluation Scoring Rubric. Proposal score was not the determining factor, nor was it written anywhere in the RFP materials that funding would be awarded solely based on scores.

EQT by Design - Social Justice and Racial Equity & Older Adult Services

EQT by Design brought forth a comprehensive set of findings and recommendations which outlined targeted areas for improvement in the City's approach to determining recommendations within the older adult services funding cycle.

1. Culturally Relevant Programming

Advocate for the investment and expansion of programming and services that are culturally relevant to the BIPOC and LGBTQIA+ communities.

2. Staff Diversity

Prioritize efforts to diversify City and program staff, ensuring representation that better reflects the demographics of the communities served.

3. Support Providers Serving BIPOC/LGBTQ+

Of the 7 recommended agencies new to older adult services funding, 5 are led by and serving people of color and other marginalized populations.



Provide support to service providers catering to BIPOC and LGBTQ+ communities, recognizing the unique challenges faced by these groups.

4. Transportation Challenges

Collaborate with relevant stakeholders to help address transportation challenges faced by older adults, emphasizing the importance of a coordinated and comprehensive approach.

5. Language Access

Invest in language access design and resources to ensure that language is not a barrier for older adults in accessing services.

6. LGBTQIA+ Services

Commit to continuous learning and growth in providing services that are inclusive and sensitive to the needs of the LGBTQIA+ community.

7. Information Distribution Networks

Improve information distribution networks to older adults, ensuring that vital information reaches them through accessible and effective channels.

CDD's recommendations include funding 14 of the 15 agencies that applied for funding, 8 of which would be new to CDD's older adult services portfolio, and of which, 5 are led by and serving people of color and other marginalized populations.

Case Management Services:

Case managers serve as advocates, assisting clients in accessing essential resources and coordinating various aspects of their care. Case management Services not only meet immediate needs but also foster long-term stability and empowerment for those facing challenges in our community.

Funding Recommendations

After reviewing program proposals, applicable data, and priority areas while centering equity, reviewers summarized, and proposed funding recommendations as follows:

Experience in case management: Established experience in providing case management and addressing the unique needs of older adults

Community focus: Deep roots in serving the older adult population, with a specific focus on the Bayview community

Alignment with RFP: Strong alignment with RFP requirements, indicating a clear understanding of the needs of older adults



Detailed and effective proposal: Well-structured and organized program design, demonstrating effective planning and execution of services

Dear Committee on Aging,

Social isolation is a paramount issue for older adults and a public health concern. Cutting funding for NewBridge's social programming, which is very successful in addressing this community health need for social outlets for seniors to stay healthy and involved in their community. NewBridge deserves to maintain this funding. (And more!!!) Services at NewBridge have been proven to be effective to meet the needs of the community. Why make cuts that undermine and undervalue the needs of older adults in Dane County?

I am requesting that the Committee on Aging REINSTATES \$277,970 to NewBridge Madison.

Bringing in 7 agencies that have not received funding for older adult services before is concerning on two levels. First, the entire city budget for older adult services is only \$838,000. How can 7 non-profit agencies be expected to adequately provide case management, culturally relevant activities, independent living support and outreach & information and referral services for all older adults in Madison who need assistance with that paltry amount?

Second, NewBridge supports the idea of funding other agencies and expand our reach so that the Madison community can better meet the needs of older adults and especially those from BIPOC and other marginalized communities such as the Southeast Asian community who we do not serve directly. However, to do this all at once without additional funding and to pull funds from NewBridge, whose work has significant impact on thousands of older adults each year, only shifts the problem.

Many of these agencies have minimal experience and expertise providing services for older adults. This is not something that just anyone can jump in and do. A couple of the agencies are requesting significant funds compared to the amount of people they will serve in their programming. We believe that offering more activities in neighborhoods can be very positive but it will take more time and resources than the current funding recommendations allow.

NewBridge is concerned the amount of funding requested/ proposed for these new agencies will severely restrict what they can do and have minimal impact. We are particularly concerned about how reducing funding for NewBridge will impact Hispanic older adults in Madison. NewBridge has helped them to become a community and they are like family to one another. Yet they are very spread out in Madison and the majority don't have peers living close by.

Wouldn't it make more sense to gradually bring in other agencies over the course of the next few funding cycles, restore some funding for NewBridge and advocate for additional funding in the meantime?

The NewBridge funding restoration request to the Committee on Aging will allow NewBridge to maintain our case management, home chore and volunteer guardian programs at the same level and not have to institute a case management waitlist again. If funding for our volunteer guardian program is not restored, who will serve the older adults in need of these services in Madison? Funding is also being proposed for resource and referral programming that seems very similar to services offered at the ADRC.

Home Chore is especially essential in keeping older adults with mobility issues from becoming homeless or having to move into assisted living. The wait list for Home Chore is already massive, the need is so great. Home Chore needs MORE funding and support to meet the need of the community, not LESS!!!

Kindly revise the budget to fully-fund NewBridge....for older adult activities, case management, homechore/foodbridge and volunteer guardian. The loss of this funding for our older adults is honestly unfathomable, it will be so excruciatingly painful for them.

Let's take care of our older adults with effective services and funding to meet their needs.

Dear Committee on Aging,

I am requesting that the Committee on Aging reinstate \$277,970 in funding to NewBridge Madison.

For twenty-three years I was an employee assistance professional at State agencies and UW-Madison. In that role, I met with employees and family members to provide consultation and problem solving. I had to be up-to-date on community resources and in particular, I researched those who stood out due to the services offered, their responsiveness, and the quality of their staff. I referred many individuals to NewBridge over the years. It was like a welcoming, one-stop shop for people needing help to remain independent, a place to gather and socialize or share a meal, and a hub for resources on elder care and caregiver issues.

My parents first used the exercise facilities at Warner Park Community Center (prior to it becoming part of NewBridge). Then Dad was diagnosed with Alzheimer's and we were in need of much more to help with that journey - learning about area resources to support both of them, as well as our family. The friends they had made at NewBridge were always there for socialization, activities, and friendship. Then the staff provided information, referral and support. During the pandemic, Deenah provided a lifeline to the outside world by delivering books for a book club. We received information about how to get meals delivered for Mom, which greatly improved her nutrition and also provided social contact. Those relationships continue today with Executive Director Jim Krueger, members of his staff, my mother and our family. People we would not otherwise have met, became dear friends and family members.

NewBridge serves a population that was diverse not only in its demographics, but in its services to meet its clientele's needs. I understand that more agencies are up for consideration for funding, that may provide similar services.

I know that NewBridge supports the idea of funding other agencies and expanding their reach so that the Madison community can better meet the needs of older adults and especially those from BIPOC and other marginalized communities. I personally believe NewBridge has a successful, efficient model. They have proven success and to cut their funding significantly will have an impact on vulnerable, older adults. For example, funding cuts for NewBridge will directly impact Hispanic older adults in Madison. NewBridge has helped them to form a community, yet they are geographically spread out in Madison and the majority do not have peers living close by. What will happen to that community with funding cuts? And that is just one example.

I know that NewBridge provides case management, home chore and volunteer guardian programs. If funding for the volunteer guardian program is not restored, who will continue to serve the older adults in need of these services in Madison? I understand that funding is also being proposed for resource and referral programming that seems very similar to services offered at other agencies, such as the Aging and Disability Resource Center (ADRC). They stand out in my mind as a model in WI county aging resource networks, without a need for duplication. But I'm biased - I have referred people to them for years and have used their services myself.

I will admit that I am somewhat ignorant of the budget process and know that tough decisions have to be made. However, I am asking you on behalf of my parents, myself, my family and the many, many friends we have made at NewBridge over the years to **restore funding** to this jewel of a resource on Madison's north side. And for the many people we have never met, who may have greater need for NewBridge services than ever before, please allow them to continue the work they do with passion and competence. I am convinced that lives depend upon it.

It is astonishing to me that at a time when the senior population is growing, and financial hardship is increasing, you would consider decreasing funding for services to this same population. What would be your rationale for such a move?

I am an 88-year old great-grandmother, retired RN, who thought I had done all the things required to have a secure retirement situation. The crash in 2008 completely wiped out all my resources, leaving me with no idea as to how to cope with my new reality.

NewBridge has provided me with the necessary help in finding needed resources, advocating for me, explaining things, guiding me through the application processes, meet deadlines, correct my mistakes, and assist on phone calls with various agencies. My case worker has been available and reliable. Why would you want to take that away from me? Or from anyone? Why would you redirect funds from a known, successful agency to a new entity that would have to start my case all over, from scratch? What do you think will happen to folks like me without these services?

I am asking that you maintain NewBridge, with adequate funding, including reinstituting their original funding level (before the proposed cuts). It is extremely stressful to me to think I will have nowhere to go when I need help.

Hello Committee on Aging Committee Members,

As you prepare to discuss the city staff funding recommendations I have a few more pieces of information as you consider how to allocate the funding for 2025.

For years, funding to provide older adult services in our community has been allocated by specific categories of need. NewBridge received small amounts of funding to provide services specifically for Black and Hispanic older adults. We also received a larger sum to provide programming for all older adults. We hosted monthly multi-cultural activities but most everything else was separated out. The past few years our Older Adult Activities program staff has revamped our approach, in response to numerous requests from older adults, to place more emphasis on activities that bring all cultures together while maintaining opportunities and culturally relevant programming for Black and Hispanic older adults. We collaborate with dozens of service providers and businesses across Dane County. But we have never had the resources to reach all of the older adults in neighborhoods across the city.

I have attached a spreadsheet showing the impact, by numbers, for each of the NewBridge older adult programs proposed to be cut by Community Development Division staff. We are on track to meet or exceed almost all of last year's goals. This includes our older adult activities program which will provide over 1,000 activities despite having one less staff person than last year.

So, what is our plan if NewBridge gets some of our funding restored? If partial funding is restored for our older adult activities we will market/offer our experience to assist new agencies receiving funding and continue limited programming for those outside of the target areas. If no funds are restored to this program the number of activities would be reduced by 50%. Our remaining funding for this program is to serve Black and Hispanic adults across Dane County. Critical services like foot care and a variety of weekly programs like free exercise classes, mental health and wellness classes and numerous socialization opportunities would be greatly reduced or eliminated. These programs are so critical to the health and wellness of older adults and in fighting off social isolation.

If partial funding is restored for case management services, we have begun discussions with one of the new agencies to provide services as needed for older adults in their target area. If no funding is restored we would seek local corporate and foundation funding or federal grant monies, however this is a very competitive process and typically limited-term. It takes a number of years to cultivate these relationships and find ones committed to supporting older adults.

If funding is not restored for the home chore or volunteer guardian program we will seek to market these programs to local businesses/foundations. Our annual and year-end fundraiser's might raise enough funds to cover the deficits for these two programs.

NewBridge has been providing quality services for 49 years. Last year we received an Aging Forward

Champion award at the Madison Senior Center's 40th Anniversary Celebration for our outstanding work in the community. Having these services available from one agency makes it easier for older adults versus having to work with multiple agencies. We understand that you may want to spread the money out across more agencies. But to make such a steep cut to NewBridge will be devastating to thousands of older adults in the community. I ask for your support in restoring some funding for the vital programs provided by NewBridge.

Hello Committee on Aging Members,

I have attached a couple handouts that discuss the significant impact the cuts to NewBridge Madison (proposed by Community Development Division (CDD) staff) will have on older adults in Madison.

The \$277,970 in proposed cuts by the city of Madison CDD staff is NOT for new programming but for programming we CURRENTLY provide. The impact of these cuts is very significant. A thousand (or more) older adults will be without programming because they don't live in, or near, one of the areas targeted by the city. Older adults in Madison are spread out throughout the community and often not within walking distance (a couple blocks) of a neighborhood center. They don't typically have a group of peers near them they can hang out with and will not have access to transportation.

Completely cutting the NewBridge older adult activities program, means the elimination of 1.5 full time staff positions. Those living on the north and southwest side of town who currently benefit from our health and wellness activities will have little to no accessible activities. It will once again isolate individuals we worked diligently to engage in activities and who depend on them each week. The older adults who participate in our activities have developed a strong trust with our organization and know we look after them and don't want to change. They hate starting all over again, it stresses them out, and many will simply give up, isolate and be unhappy again. They will sit around more and their health will deteriorate more rapidly. This year we have significantly increased the weekly programming (available on the north and west sides of Madison) available for the 120 + older adults in our Hispanic program. We will have to reduce the programming by half. We also have an accessible bus to help us transport participants and are scheduled to get a second bus this winter. If our budget is totally cut there will be no second bus. They are very upset by the impact this will have on them.

The proposed cut to our case management program will force NewBridge to lay off one or more case managers. This will mean **80-100 lower income older adults facing difficult situations will not get the timely help they need (if at all)** each year. NewBridge works with low income clients, for as long as they need, to help them access essential resources and services. The number and severity of needs and the complexity of these issues is not something just anyone can handle. The majority of these individuals don't have anyone able to help them. Having to wait for help or only receiving limited-term assistance adds lots of stress and worry for those who already feel a loss of control over their lives.

Please vote to restore funding to NewBridge Madison, at the October Committee on Aging meeting, for these two essential programs (older adult activities, case management). that the Madison CDD has proposed be cut from our budget,
