Please consider this letter, to be submitted to the Habitat Stewardship committee, and the enclosed material our plan to remove one tree in the public right of way at 4114 East Washington Avenue in Madison. I've included two pictures identifying the tree we'd like to remove. Again, the reason we want to remove the tree is to make the signage more visible for existing and future tenants at the property.
